Essential requirements

- Senior Vocational Training Technician
- Oral and written knowledge of the two official languages of Catalonia.

Skills will be valued

- Experience working with experimental animals (small rodents) is a plus.
- Experience in molecular biology techniques: Western blot, ELISAs, confocal and inverted microscopy, PCR, IHQ, flow cytometry...
- Experience in cell biology techniques: primary cultures and cell lines (especially blood cells).
- Experience in techniques for obtaining DNA, RNA and protein from animal tissue samples.
- Knowledge of rodent surgery.

Functions

- Technical and functional studies for phenotypic and functional characterization of inflammatory cells: monocytes and macrophages.
- Inflammatory response studies in animal models defective in different genes.
- Protein, mRNA and miRNA expression studies in human/animal biological samples aimed to identify and characterize the role of different lipoprotein receptors and inflammatory molecules.
