#### **Essential requirements**

- Minimum qualification required: Advanced Studies (Bachelor's degree, Diploma or Degree) in Health Sciences or equivalent
- Specific training in clinical trials (Master's degree in clinical trial monitoring) or previous experience of 2 years in a similar position.
- Training in Good Clinical Practice and Quality standards.
- English and computer skills
- Oral and written knowledge of the two official languages of Catalonia

#### Skills will be valued

- Ability to integrate into work teams and contribute to maintaining the unity of the group.
- Demonstrable experience in clinical trials in the area of oncohematology.
- Master's degree in clinical trial monitoring.

#### Functions

- Coordination and monitoring of clinical trials of the Hematology Service / Hematology and Transplant Group of the Fundación Instituto de Investigación del Hospital de la Santa Cruz y Santo Pablo in a subgroup of diseases.
- Manage prescreening visits for assigned diseases, initiation, monitoring and closure of clinical trials.





- Schedule visits and testing of clinical trial patients according to the protocol of each study.
- Follow-up of medium and long term trials once patients have completed the trial.
- Data entry in the electronic logbook of each trial.
- Reporting adverse events and serious adverse events, as well as their follow-up.
- Resolution of incidents.
- Providing oral medication to the patients in the trial, controlling its traceability.
- Coordinate with the different care areas and professionals of the Hematology Service of Santo Pablo.
- Report to the Head of Trial Management Area of the Hematology Service/Hematology and Transplant Group.
