

INTERNAL PROMOTION CALL

The Institution

The **Fundació Institut de Recerca de l'Hospital de la Santa Creu i Sant Pau** is a scientific foundation whose mission is to improve the health and quality of life of the population, through the production and dissemination of scientific knowledge, the training of researchers at an international level and the promotion of innovation and health through the incorporation of medical advances in clinical practice and health policies. Created in 1992, in 2003 it was attached to the Autonomous University of Barcelona (UAB) and since 2011 it has been part of the CERCA Program of the Generalitat de Catalunya.

For the Foundation, it is a priority to ensure that the recruitment of the most suitable candidate to fill a job is done through an open, transparent and merit-based (OTM-R) selection process. Following these guidelines will promote the mobility of staff, the exchange of knowledge and, ultimately, the increase in the quality of teaching and research. Faithful to the commitment to the European Union's human resources strategy, our institution's personnel selection and recruitment procedures are governed by a set of basic principles that guarantee everyone equal access to employment. Therefore, the constitutional principles of equality, merit and capacity are followed, respecting in any case the national and international regulations in force in this area, specifically the European Charter for Researchers and the Code of Conduct for the recruitment of researchers (CC). The principles of C&C are applicable for the recruitment of any staff of the institution, regardless of their professional category.

About the Unit / Group:

Epidemiology, Public Health and Primary Care: Research in this area involves the study of population health and its social, political and environmental determinants with special attention to inequalities and their consequences. It also evaluates the effectiveness and health impact of public interventions and policies such as the promotion of evidence-based medicine practice in order to make health intervention more effective, appropriate and safe. Also important is the development and evaluation of methods or strategies to improve the generation, evaluation, communication and transfer of scientific evidence. Finally, this area studies the epidemiology of communicable diseases in the population of Barcelona, with special attention to the impact of prevention and control strategies developed. The aim of this

area is, therefore, to achieve public health wellbeing by improving medical policies and management.

Main lines of research:

- Evidence-Based Medicine: systematic reviews, clinical practice guidelines and clinical trials.
- Evaluations of health services.
- Methodological research.

Essential requirements

- Minimum qualification required: Doctorate in Health Sciences (less than 5 years ago).
- Oral and written knowledge of the two official languages of Catalonia.
- Advanced level of English
- Advanced level of office tools (Excel, Word, Power Point , etc.).
- Experience in developing systematic reviews and their different modalities (rapid reviews , diagnostic accuracy reviews, prognostic reviews, overviews , etc.)
- Experience in database management and statistical data analysis

Skills will be valued

- Previous experience in coordination of multi-centre projects in the health area.
- Experience in the development of health knowledge transfer products (e.g. health technology assessments)
- Experience in the preparation of manuscripts for publication in biomedical journals
- Experience in the use of statistical analysis tools (SPSS, Stata , R, etc.)

- Coordination of projects to carry out systematic reviews and literature updates at European and international level.
- Logistical coordination of studies and working groups
- Conducting and supervising statistical analyses
- Leading the elaboration of reports and publications

PERMANENCE COMMITMENT: *Selected persons who will hold the summoned or vacant position, will not be able to apply for a new call until 1-year period has expired. In case of part-time job positions, this period will be of 6 months. In both cases, the period will compute from the date of publication of the resolution. The vacant summoned, and the ones that derive from it (intern movements), will be successively covered on the same proceeding among the submitted candidates to each particular call, regardless of whether this entails coverage of places in turns other than the call.*
