The Institute

The **Santa Creu i Sant Pau Hospital Research Institute Foundation** is a scientific foundation which mission is to improve health and quality of life of the population, through the production and dissemination of scientific knowledge, training of researchers to an international standard, and promoting health innovation and the incorporation of medical advances in clinical practice and healthcare policies. Created in 1992, the institute was attached to the Autonomous University of Barcelona (UAB) in 2003, and since 2011 it is part of the Government of Catalonia's CERCA Programme.

For the Foundation, it is a priority to ensure that the most suitable candidate is hired to fill a job through an open, transparent and merit-based selection process (OTM-R). Following these guidelines, staff mobility, knowledge exchange and, ultimately, the increase in the quality of teaching and research will be enhanced. Faithful to our commitment to the European Union's human resources strategy, our institution's personnel selection and recruitment procedures are governed by a set of basic principles that guarantee equal access to employability for all. About the Group:

The Complex Diseases Genomics Group is an interdisciplinary translational research team, with experience in several scientific domains: Big Data Omics, Molecular Biology, Statistics and Bioinformatics. To complete the current new lines of research on Genomics of Thrombosis and Sports Medicine, the Vascular Biology Group (LABVI) has recently been integrated together with the Vascular Surgery and Angiology clinical team of the Sant Pau Hospital.

This means new capabilities for the group (expertise in cell and tissue biology, biochemistry of inflammatory mediators and functional analysis), creating a unique line of vascular research with a more competitive orientation and great scientific potential.

The resulting group constitutes a consolidated basic and clinical team of translational and innovative research, with the aim of transferring all the new knowledge that is generated in omic and molecular research to clinical practice, working in the different research areas, with a approach towards personalized and precision medicine.

The group's main lines of research are:

- Angiology and Vascular Biology
- Venous thrombosis and thrombosis and cancer
- Genomics in sports medicine.
- Transversal research areas

Essential requirements
